In 2023, the State of New Jersey approved a license permit allowing special occasion events under certain circumstances to be held on preserved farmland. Some of these events can be weddings, concerts, etc. but the permitting process is not as easy as it sounds and Municipal Clerks in the Municipalities that have one of the 2600 preserved farms that cover 240,000 acres in the State will see all the steps one needs to know for a preserved farm to host an event.
