

# Did you know???

### Daniel's Law Update:

Daniel's Law has been revised and is expected to be signed into law soon. Named for the son of a New Jersey federal judge who was killed by a deranged litigant, Daniel's Law is designed to limit the disclosure of the home addresses of judicial officers, prosecutors, law enforcement officers, and immediate family members of each who are residing in the same household. The big change is that there is now a process to be administered by the Department of Community Affairs (DCA) by which a protected official must make an application in order to request protection under the law. The legislature created a process for this, including providing funding and authorizing the state to hire a consultant to create a web-based portal for submission of requests. DCA will receive, review, and either approve or deny all applications, and there will be carve-outs for notices for development applications under the Municipal Land Use Law; election petitions and other materials; homes sales, lien, encumbrance and other real estate recordings; class action notifications; and other "legal, promotional, or official notice which would otherwise be provided to the person..." The Department of Banking and Insurance is also empowered to issue rules and regulations within eighteen months consistent with the new law. The law forbids local government agencies from "knowingly" engaging in the "post, repost, publish or republish on the Internet of the home address" of someone who has applied and been approved by DCA under the law. Anyone who violates the law knowingly is liable for a \$1,000 fine plus reasonable attorney's fees and punitive damages.

Below is a decision involving the discretionary authority of a Municipal Clerk with respect to gauging signatures on ballot initiatives and voting matters. It is a cautionary lesson and was "published," meaning it is binding statewide precedent for all Municipal Clerks.

The issue in the case was evaluating the similarity of signatures on a petition as compared to the voter registration logs. While the standard is discretionary for Clerks, the court has relaxed it somewhat in favor of inclusion of signatures.

APPROVED FOR PUBLICATION

Twp. of Montclair Comm. of Petitioners v. Twp. of Montclair, Appellate Division, Judge Fisher

Defendant township appealed from the judgment of the trial court. Defendant had enacted an ordinance adopting rent regulations. Plaintiffs wished to challenge the ordinance in the next election. Due to the State of Emergency imposed for the COVID-19 pandemic that banned door-to-door signature gathering, plaintiffs set up a website that allowed voters in the Township to read the ordinance and referendum petition before proceeding to a signature page where voters were required to provide the statutorily required information along with an electronic signature. After obtaining the required registered voter signatures, plaintiffs filed the referendum petition with the Township Clerk. However, the Clerk rejected over a hundred signatures, concluding that the voter's e-signature did not match the signature in the voter registration system. The Clerk calculated that plaintiffs' petition was short by 106 signatures. Plaintiffs provided updated e-signatures that were again rejected by the Township Clerk on grounds that they did not match the pen-and-ink signatures in the voter system. Plaintiffs filed suit, arguing that the Clerk's decision was arbitrary. The trial court ultimately ruled in favor of plaintiffs, ruling that the Clerk's grounds for rejection were arbitrary and capricious as plaintiffs' petition met the statutory requirements. On appeal, the defendant argued that the uncontested facts showed that the Clerk had rejected signatures that did not resemble the voters' signatures in the voter system. The court rejected the defendant's argument and affirmed the trial court. The court noted that the referendum petition statute merely required that petition signers be qualified voters, and had no requirement that the appearance of voters' signatures match that in the voter registration records. (Approved for Publication)

Agendas are permanent records and are to be kept for infinity-they are not to be discarded.

New Jersey recently enacted Assembly Bill No. 2877. In general, the Act requires that a creditor that has initiated a foreclosure proceeding on commercial property, within 10 days of initiating the preceding, notify the Municipal Clerk where the property is located that a foreclosure has been filed against the property. The Act also requires the Municipal Clerk or other responsible local official to notify a foreclosing creditor in the event that a commercial property in foreclosure becomes vacant or if the exterior of the property is found to be a nuisance or in violation of any applicable state or local code.

## Did You Know???

### **Election Updates:**

Police Officers will no longer be permitted to stand within 100 feet of a polling place or ballot drop box under a new law signed by Gov. Phil Murphy on January 18, 2022.

The new law includes both on-duty and off-duty law enforcement but would still permit local and county police to assist in the transportation of ballots and to enter polling locations in the event of an emergency.

Election boards are now barred from requesting law enforcement assistance at a polling place.

The new prohibition does not prevent officers from voting, nor does it prevent officers from remaining in their homes if those fall within the 100-foot limit.



Raffle participants are not permitted to purchase raffles of any kind with electronic payment options such as PayPal, Venmo, Apple Pay, Credit Card squares, etc. If a participant wants to purchase a raffle they must continue with the old fashion way of payment via cash or check.

### Some IMPORTANT Election day reminders!!!!

### 19:62-9 Open hours of office of Municipal Clerk on election days.


9. The office of the Municipal Clerk shall be open from 6:00 a.m. to 8:00 p.m. on the day of an election to provide replacement ballots or provisional ballots to voters, receive voted ballots being deposited in person by voters and permit individuals with disabilities to vote using a voting machine that is fully accessible to such individuals. During this time, such appropriate staff shall be available for election purposes at the office of the Municipal Clerk as may be required by the County Board of Elections to ensure the proper administration of the election process.

(Even if your municipality is closed on Election day, you are working!)

# 19:18-3. Municipal Clerk's office open until all ballot boxes delivered; record of times of delivery

The Clerk of the municipality shall attend his office on election day, or appoint one of the clerks in his office to act for him, and keep his office open from the time the polls shall be closed until all the ballot boxes used at the various polls in the municipality at such election shall have been delivered at his office.

The Clerk of the municipality or his subordinate whom he may have appointed to act in his stead shall enter in a book to be kept for that purpose the exact time when each ballot box may be delivered at such office, the district whence it was brought, names of the members of the district board delivering it, and the name of the Police Officer or other witness who may accompany them, and any other particulars he may deem important; such book shall be filed in the office of the Municipal Clerk and be preserved by him for two years.










## A Message From Incoming President Denise Cafone


