State Department of the Treasury Russia-Belarus Law:

Temporary Suspension of Enforcement

NOTICE REGARDING N.J.S.A. 52:32-60.1 (Entities Engaged in Activities in Russia and Belarus) N.J.S.A. 52:32-60.1 requires the Department of the Treasury (Treasury) to establish a list of persons and entities engaging in prohibited activities in Russia or Belarus and to update that list every six months. The law also prohibits the State from engaging in certain activities with a person or entity identified on the list as engaged in prohibited activities or whose subsidiaries, parents, or affiliates are so engaged. The prohibited activities include: (1) entering into or renewing contracts; (2) approving or renewing Public Works Contractor Registrations; (3) approving economic development subsidies; (4) providing tax clearance certificates; and (5) certifying urban renewal entities for the purposes of the "Long Term Tax Exemption Law." On August 4, 2023, a company obtained a temporary restraining order (TRO) from the United States District Court for the District of New Jersey, which enjoins the State from enforcing N.J.S.A. 52:32- 60.1 against that company on the ground that the statute is likely inconsistent with federal law. The lawsuit remains ongoing. The State continues to defend the law in court. Nonetheless, in light of the Court's decision, and to protect the integrity and fairness of the State's business dealings, including the procurement process, the State and its agencies and instrumentalities will be voluntarily applying the terms of the TRO to all persons and entities engaging with the State until further order of the Court. Pending further order of the Court, the State will remove the list from its website, and suspend further implementation of N.J.S.A. 52:32-60.1. Treasury recommends that State agencies should continue to defer to and follow any applicable federal laws, regulations, or guidance regarding sanction programs administered by the U.S. Department of Treasury's Office of Foreign Assets Control.



A MESSAGE FROM MCANJ PRESIDENT MICHELE BOBROWSKI

Where have the last three months gone? Time has flown by and it has been a super busy three months for me. When I sat down to write an article for the October Edition of the Quill and I thought of what I had done, I could not believe all that I accomplished in such a short period of time. In July and August, I facilitated two Athenians Dialogues at two great locations; the National Guard Training Facility in Sea Girt and the Springfield Fire Department in Union County. Attendees were able to tour and learn about these two facilities as well. Other Athenian Dialogues are being scheduled and as soon as I have more details as to final locations and arrangements, I will make that announcement as I continue the "Taking it to the Streets" series across New Jersey. Please be on the lookout for that information.

MCANJ had two Conference Committee Meetings with a rough outline of potential sessions. The Committee is ensuring that CEUs for all disciplines are available. To my fellow Registrars, I've heard you! We currently have 4 CMR credits for the Conference. Outside of work and Township Meetings, I assisted a neighboring Borough that needed a Municipal Clerk to cover two of its meetings. According to the Mayor, it turned out to be two of the longest meetings ever - lol.

I moved my son to college in Maine and by the time you read this Quill, I would have attended three County Meetings, stopped by a few Municipal Clerk Offices to introduce myself and offer words of encouragement and pledge my support in case they ever need anything. Finally, I went on the IIMC Study Abroad in Belgium and Amsterdam with 47 Municipal Clerks across the United States and Canada and a Municipal Manager Conference. All of that mixed with Covid and Lyme disease - Let's just say, It's been a roller coaster ride these last three months. However, I wouldn't change a thing. I have met some amazing Municipal Clerks across the State of New Jersey, the United States, Canada and Europe! It has been a highlight of my Municipal Clerk career and I've made memories to cherish for a lifetime. I encourage all of you to go on the IIMC Study Abroad at least once during your career.

As the self-appointed "event planner", I never have the opportunity to relax so I didn't know what to expect during the IIMC Study Abroad except what was on the itinerary. Our group visited and toured so many Town Halls, met local Mayors and Town Clerks who organized such wonderful events so we could experience the culture of their Country. Some towns were established as early as the 1200s where their towns halls were painted in gold. Can you imagine that here? In Bruges, I toured the Belfry Tower, a medieval tower built in the 1200s that housed the City's archives and Municipal Seal. This particular tower is 272 feet tall with 366 narrow stairs that one would have to climb to retrieve items. I was already gasping for air when I realized I was only half way up.

Thank God, I don't have one of those towers and had to climb all of those stairs to do OPRA requests because I can tell you right now, I would probably quit! It was a good workout though. There was a fire in that tower in 1741 that surpassed those 366 stairs and that section was never rebuilt. I wondered why there was a fire - someone didn't want to climb those stairs, that's what I think!

We learned that Mayors in the Netherlands are appointed by the King for a six-year term and not by the public. If you do not like your Mayor, but the King does, you are stuck with the Mayor because only the King can remove him. Upon their appointment, Mayors are bestowed with ceremonial necklaces by the King. These necklaces are worn to municipal meetings and outings. At the bottom of the necklace is a medallion that has two sides. One side is for municipal affairs and the other is for national affairs. Depending on what the Mayor is doing will depend on what side the medallion is on. All of the Mayors whom we encountered graciously welcomed us and explained how they were appointed. Some had been Mayors in other towns prior to they currently served. During the Study Abroad we attended the IIMC Region 12 Dutch Municipal Clerk Symposium where we met Municipal Clerks throughout Europe. Listening to these Municipal Clerks I realized how lucky and fortunate we all are here in New Jersey. We are provided multiple educational opportunities and a State Statute that outlines our job duties which these Municipal Clerks are wanting to aid them to where they currently serve.



The Need for Liquor License Reform by Assemblyman Joe Danielsen

In 1947, New Jersey adopted rules to determine how many liquor licenses each municipality could grant to local business owners based on a population formula. As our State's population grew, so did the call to revise the population formula. Today, based on amendments passed nearly sixty years ago, current law allows one consumption license for every 7,500 residents in a municipality.

The sale of alcohol is a major economic driver in our State, and the ability to secure a liquor license is highly sought after and expensive due to their limited supply. That's why it may surprise many to learn that individuals and corporations across the State are hoarding almost 1,300 inactive licenses. And even though these licenses are not in use, they still count against their local municipal government's limit under the population formula.

Because of a lack of availability, many entrepreneurs looking to open a bar or grow their restaurant's offerings are unable to secure the liquor licenses they need to run their businesses. Not only is this bad for business, but it also impedes economic development in our communities.

As Chairman of the Assembly Oversight, Reform and Federal Relations Committee, I believe a comprehensive review of New Jersey's liquor laws is long overdue. We must take action to bring our State into the 21st century with responsible liquor license reform. That is why I have begun a thoughtful review of these statutes, seeking to implement moderate improvements that will benefit all citizens.

Over the past two legislative sessions, I have held committee hearings, met with stakeholders, and spoken with everyday citizens about how best to review, rewrite, and restructure our liquor laws.

The feedback I have received was instrumental in drafting my legislation, <u>A5461</u>, which would allow municipalities to transfer inactive alcoholic beverage retail licenses, and enable retail distribution licenses to be converted into consumption licenses. And I am proud to say that to date, a strong consensus is building in favor of this measure.

Under my legislation, there are four methods to move inactive licenses (defined as being unused for two years, could be transferred to a different municipality). However, I want to highlight two of these proposals that I feel will do the most to solve the problems I have laid out.

In the first procedure, prior to the expiration of a license the license holder may apply to the municipality that issued the license and a contiguous neighboring municipality to use that license in connection to redevelopment, improvement, or revitalization areas. This procedure also gives municipalities enhanced oversight on these transfers, as both municipalities involved would have to adopt identical resolutions authorizing the transfer.

The second procedure meanwhile, allows municipalities that have reached their license cap to acquire inactive licenses by requesting an RFP (Request for Proposal) from any license holder in the State. The host municipality would approve the sale and transfer; and once they have done so, the transfer would take place. As a check on this procedure however, a receiving municipali-

ty would only be allowed to acquire one license through this process each year. And any transferred license would have to be used within two years, or it would expire.

This commonsense approach my legislation takes would allow overstocked municipalities that have too many inactive licenses to provide an open market source for bidding on their purchase. I believe this is a win-win for both the purchasing town and the seller, and it will offer a solution to the current issue without adding any additional licenses to the marketplace.

Since discussions on this topic began, I have been impressed and pleased by the openness of those who would be impacted by any changes to license protocols. Their opinions and ideas have allowed me to create legislation that I believe is in the best interest of all New Jersey residents.



In early January, Governor Murphy announced his own proposal where his vision is to grow the industry by allowing for increased licenses each available at a lower price point. Recently, he again stated that he is seeking comprehensive liquor reforms. These statements kick the issue back into the hands of my colleagues in the legislature to seek a resolution.

I remain concerned that the Governor's plan has tremendous economic impact by flooding the market with additional license holders that will devalue all existing current license holders' assets, causing tremendous economic loss, economic instability all while doing nothing about the large number of inactive licenses still available.

The process of seeking change and improving the State's liquor licensing system will begin in earnest after the November elections. It is my hope that we can find common ground and address this issue for the betterment of all.

GENERAL ELECTION TIMELINE CHANGES & OTHER LEGISLATION UPDATES

Governor Murphy signed A-5175/SCS-3519 on July 21st , which makes changes to General Election timelines.

The deadline changes that affect municipalities include:

O Moving the date for a candidate to accept the nomination from 70 days to 81 days prior to the general election.

O In the event of a vacancy, moving the date for new petition submittals from 64 days to 75 days before the day of that election.

O When a vacancy occurs after a candidate has been nominated in the primary election for the general election, the date moves from 56 days to 70 days before the general election. or in the event of inability to select a candidate because of a tie vote at such primary, a candidate shall be selected by the political county committees, depending on which office. The date a selection made by the political county committee changes from 54 days to 68 days.

O Moving the date, the county clerk must have ballots ready for the printer to 45 days before an election and moves the printer deadline for federal primary and general elections from 50 days to 64 days prior.

O Moving the date the Board of County Canvassers meets after an election from 13 days to 15 days.

O Moving the time a candidate has to apply to a judge for a recount from 17 days to 3 days following certification.

O Moving the date of filing county or municipal ballot questions with the county clerk from not later than 81 days to 88 days.

O Moving the date a municipal ballot question must be submitted to the county clerk by citizen petition from 67 days to 74 days. It also moves the deadline for inclusion on the sample ballot from 67 days to 74 days.

O Changing the date that a district election officer has to keep the voting machines locked from 15 days to 13 days.

O Moving when boards of education of a type II district may call a special election from the Third Tuesday in September to the last Tuesday in September and expanding the authority of the Commissioner of Education to change authorized special school elections if they fall within 45 days of the general election.

O Moving the date, a school board candidate can withdraw from 70 days prior to an election to 81 days to avoid having their name on the ballot.

O Moving from 64 days to 75 days that candidates for all elective offices have to file with the municipal clerk prior to a regular municipal election.

Moving the reorganization date from January 1 to January 15 for municipalities that hold non-partisan elections in November.
 Prohibiting fire district elections from being held prior to 45 days prior to the primary or general election.

Other bills signed by the Governor:

<u>c.93</u> - Requires sellers of real property and landlords to make certain notifications regarding flooding. The Department of Community Affairs will create a model notice used by realtors and landlords to notify prospective buyers or renters of flooding risks to the property before they become obligated under any contract. The form would indicate if any of the property is located in a Federal Emergency Management Agency Special Flood Hazard Area or a moderate Risk Flood Hazard Area and if the property has ever experienced any flood damage in the past. To support consumer protections, a tenant may terminate the lease without penalty at any time, if the landlord fails to disclose this information and after they become aware that the property is located in a flood plain.

<u>S-3125</u> - Expands "Daniel's Law" to prohibit disclosure of personal information concerning child protective investigators. This also has some other changes to the law regarding ensuring websites comply.

A MESSAGE FROM MCANJ PRESIDENT MICHELE BOBROWSKI

As for the Municipal Clerk world here in New Jersey, Legislative Chair Michele Siegfried of Robbinsville and I met with the NJLM and Officers of the NJ Institute of Local Government Attorneys to review a draft of the OPMA and Remote Meetings Legislative Proposal in July. The MCANJ Legislative Committee made recommendations that would impact Municipal Clerks. There were a few comments made by our Legislative Committee that we shared, and those concerns were incorporated into the draft. Currently, the Conference of Mayors is reviewing the proposal along with the NJLM Intra-Affairs Committee. Frank Marshall, Associate General Counsel of NJLM will be one of our guest speakers at the Legal Defense Fund (LDF) seminar on December 5th in Woodbridge to discuss this new legislative bill that is being proposed and the changes being incorporated. If your municipality is conducting Zoom meetings, you are going to want to make sure you attend this seminar to hear the changes that will be incorporated into the bill and the requirements of attendees and Township Councils who want to utilize the Zoom platform to be in compliance with the OPMA. The Legal Defense Fund Committee has been busy securing speakers for the December 5th seminar and will hit on some topics that will have a big impact on you, especially if you receive comp time (which I hope you are not) or any type of compensation outside of your regular office hours that can be construed as "comp time". Example: You worked 16 hours for the election and are being given a day off because of the extra hours worked. It's considered "comp time" and not permitted. One of our former Municipal Clerks who is now working at the New Jersey Department of Labor and is the Liaison between the Wage and Hour Division and Government Bodies will be speaking on this very subject along with accrued sick time which has been another topic for many nearing retirement due to the NJ Sick Leave Policy. The NJ Comptroller has been reporting on Towns not complying with the NJ Sick Leave laws. We were advised at the NJ Municipal Manager Conference that comp-time is up next to be investigated which is why we are going to be discussing this topic on December 5th for Municipal Clerks-MARK YOUR CALENDERS LDF MEMBERS!!!!

These past 3 months have been busy, and as we look ahead, we continue to keep busy with the NJLM in Atlantic City from November 14-16, 2023. Come visit us at booth #706 for a really cool giveaway for Municipal Clerks geared towards our conference theme. I will be there Tuesday afternoon and all day Wednesday hanging out with Executive Director Joel Popkin, Asst. Executive Director Vinnie Buttiglieri, and Steve Berry, retired Clerk of Glen Ridge at our booth to meet you all, the Legal Defense Fund (LDF) Seminar is on December 5th in Woodbridge for Legal Defense Fund members. **DO NOT FORGET** you have until November 1st to register for the LDF!! At the League last November, MCANJ had three speakers answer your most pressing questions on Open Public Meetings and Executive Meeting Etiquette. The session was well received, and the room was packed. These three speakers were Richard Cushing, 2022 President NJILGA; Gebhardt & Kiefer, PC, Leslie A. Parikh, Esq. and John C. Gillespie of Parker McCay.

Some Executive Session/Rice Notice Questions Answered:

- Who is allowed in the Executive Session? If an employee was given a Rice Notice, that does not give the right for the employee to be present in the Executive Session. If the Governing Body wants to invite the employee to the Executive Session, then the employee can come in and the Governing Body can listen to the employee's perspective if they wish because depending on the circumstances there are two sides to a story. Letting people into the Executive Session though is not a good idea. Legislation allows the Governing Body discretion to conduct their meetings as they see fit.
- Attorney/Client Privilege is for the client, not for bringing someone in.
- How should Executive Session minutes be approved? Can discuss issues/minutes in Executive Session but are approved in open session.
- Executive Session minutes should reflect who was present, time meeting began/ended, and brief description of discussions.
- When should the Municipal Clerk be asked to leave Executive Session? The Municipal Clerk is to be at <u>EVERY MEETING AND BE</u> <u>THE ONE TAKING THE MINUTES!</u> If the Municipal Clerk has a conflict or a personnel matter, then the Township Attorney can be appointed the Deputy Clerk for that discussion only or an Independent Municipal Clerk can be brought in. Bringing in your Deputy Clerk causes conflict in the Municipal Offices and its not recommended that a Deputy Clerk sit in for the Municipal Clerk on their personnel matters.
- When should minutes need to get done by? If you meet once a month, minutes should be done for the next meeting. Minutes do not need to be verbatim.
