**RESOLUTION 2020-222**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM PROVIDING FOR  
A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW  
JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12**

**WHEREAS**, the Township Committee of the Township of Mendham is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq.; and

**WHEREAS**, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

**WHEREAS**, it is necessary for the Township Committee of the Township of Mendham to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

- (1) Matters Required by Law to be Confidential: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.
- (2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.
- (3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
- (4) Matters Relating to Collective Bargaining Agreements: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
- (5) Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.
- (6) Matters Relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.

(7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege: Any pending or anticipated litigation or contract negotiation in which the public body is, or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.

(8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose right could be adversely affected request in writing that such matter or matters be discussed at a public meeting.

- ***Chief Financial Officer***

(9) Matters Relating to the Potential Imposition of a Penalty: Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Mendham, in the County of Morris and State of New Jersey, assembled in public session on **November 24, 2020 at 6:00 PM** in the Township Municipal Building, 2 West Main Street, Brookside, New Jersey, that the Township Committee shall meet in Executive Session, from which the public shall be excluded, for the discussion of matters relating to the specific items designated above.

**BE IT FURTHER RESOLVED** that it is anticipated that the deliberations conducted in closed session may be disclosed to the public upon the determination of the Township Committee that the public interest will no longer be served by such confidentiality.

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM AUTHORIZING TOWNSHIP ADMINISTRATOR TO EXECUTE NJPDES/TREATMENT WORKS APPROVAL APPLICATION FOR THE COMMUNITY OF SAINT JOHN THE BAPTIST CHURCH - BLOCK 104 LOT 22**

**WHEREAS**, the Township of Mendham has been requested to endorse (without assuming responsibility therefore) a Treatment Works Approval (TWA) application submitted by the COMMUNITY OF SAINT JOHN THE BAPTIST CHURCH at 82 West Main Street, , Block 104 Lot 22; and

**WHEREAS**, NJ Department of Protection regulations require that the governing body of the municipality in which the applicant's property is located must consent to the submission certifying that the proposed project is in conformity with the municipality's ordinances; and

**WHEREAS**, the proposed septic rehabilitation program outlined in a letter dated October 20, 2020 by Applicant's Engineer, Ferriero Engineering, is not changing the use of the property and consequently is not contrary to the existing ordinances of the Township.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** by Township Committee of the Township of Mendham as follows: the Township Administrator is hereby authorized to sign the Governing Body consent line in section A-1 on page 1 of the WQM-003 form attached to the TWA application.

It is further noted that by so approving the execution of the WQM-003 form, the Township of Mendham assumes no liability for, nor does it enter into any undertaking or other agreement to maintain, operate, own, repair or support the associated sewerage treatment plant and that the sole purpose of such consent is to allow the project to move forward.

**RESOLUTION 2020-225**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM TO AUTHORIZE THE RENEWAL OF A TEMPORARY CERTIFICATE OF OCCUPANCY FOR OUTDOOR DINING IN TENTS**

**WHEREAS;** March 21, 2020, Governor Murphy signed Executive Order No. 107 which limited restaurants to offer only food delivery and/or take-out services in accordance with their existing liquor licenses to mitigate the spread of COVID-19; and

**WHEREAS,** on June 3, 2020, Governor Murphy signed Executive Order No. 150 which permits restaurants to offer in-person service at outdoor areas starting at 6:00am on June 15, 2020, provided that the establishment complies with certain safety, health, and social distancing requirements issued by the New Jersey Department of Health; and

**WHEREAS,** on May 26, 2020 the Township Committee authorized the issuance of a temporary certificate of occupancy for outdoor dining in tents to any Township restaurant or food establishment that was lawfully operating prior to the March 2020 closure of all indoor eating establishment; and

**WHEREAS,** commercial activities in the Township of Mendham are regulated through the Land Use/Site Plan Process to address public health and safety issues; and

**WHEREAS,** to formally seek Land Use and Construction Code compliance for outdoor dining requires an extensive, regulated process thereby negating the goal of the Governor to restart the State economy and the Township Committee's support of the phased reopening effort.

**NOW THEREFORE BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM that:**

1. On an emergency basis due to the time constraints impacting the restarting of the State's economy, the Township Committee hereby waives existing zoning restrictions that would prevent the serving of food outside of the normal restaurant structure using tents or other temporary structures provided that temporary structure is on property owned by the applicant.
2. On an emergency basis due to the time constraints impacting the restarting of the State's economy, the Township Committee hereby waives existing detailed site plan review procedures and substitutes the abbreviated procedures outlined in this Resolution provided that temporary structure is on property owned by the applicant.
3. The Zoning Official is hereby authorized to issue a temporary zoning use permit for any Township restaurant or food establishment that was lawfully operating prior to the March 2020 closure of all indoor eating establishments. Said temporary use permit shall remain in



effect as long as the emergency health proclamation remains in effect unless suspended by the Township Committee.

4. The Construction Official is hereby authorized to issue a Temporary Certificate of Occupancy for any Township restaurant or food establishment that was lawfully operating prior to the March 2020 closure of all indoor eating establishments upon approval by the relevant construction code officials, the Fire Prevention Official, the Police Chief, and the Local Board of Health Officials. Said temporary use permit shall remain in effect as long as the emergency health proclamation remains in effect unless suspended by the Township Committee.
5. In order to assist the local businesses in this process, the Township Committee hereby authorizes the waiver of all fees relating to the required inspections and licensing necessary to reopen a local business for outside dining.
6. If the local business establishment had an approved liquor license prior to the March 2020 closing, the Township Committee agrees to allow the extension of the use of that license to an outside eating area owned by or under the legal control of the license holder subject to the temporary approvals issued by the State Alcoholic Beverage Control Board and required local approvals of the Township Clerk and Police Chief without further review by the Township Committee.
7. The above approvals do not apply to structures located upon public property.

Reid Recycling from making any reportable contributions through the term of the contract, and

**WHEREAS**, the Chief Financial Officer has certified in writing hereon that funds are available.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Mendham authorizes the Township Clerk and Mayor to enter into a contract with J.H. Reid Recycling as described herein.

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM AUTHORIZING THE EXTENSION OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL ARCHITECT SERVICES WITH CORNERSTONE ARCHITECTURAL GROUP FOR ADDITIONAL SERVICES**

**WHEREAS**, the Township Committee authorized the award of a non-fair and open contract to Cornerstone Architectural Group to perform a Feasibility Study on Town Hall via resolution 2020-089 on May 11, 2020 not to exceed \$22,000; and

**WHEREAS**, the Township of Mendham via resolution 2020-153 extended this contract by an additional \$10,000 for the preparation of plans for submitting a New Jersey Library Construction Bond Act Application for the renovation and/or construction of the Mendham Township Library; and

**WHEREAS**, the Township of Mendham via resolution 2020-168 extended this contract by an additional \$11,050 for plans that were outside the scope of the original project but necessary if the Township was to receive the total information necessary for a full analysis of the alternates available to the Township; and

**WHEREAS**, the Township of Mendham via resolution 2020-181 extended this contract by an additional \$5,500 for floor plans and a schematic design for a new police facility on West Main Street; and

**WHEREAS**, the Township Committee of the Township of Mendham wishes to extend Cornerstone's current non fair and open contract to further study and refine the exterior image, interior floor plan layout and site placement for a new Police Department Headquarters; and

**WHEREAS**, the Chief Financial Officer has certified as to the availability of funds pursuant to *N.J.A.C. 5:30-5.4*, said funds not to exceed \$7,500 to be encumbered from account 0-01-20-100-028 for \$500 and account C-04-67-990-005 for \$7,000.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Mendham authorizes the Mayor and Township Clerk to extend the current contract with Cornerstone Architectural Group not to exceed \$56,050 total as described herein.

**RESOLUTION OF THE TOWNSHIP OF MENDHAM TO APPROVE A SHARED SERVICE AGREEMENT WITH THE MORRIS COUNTY UTILITIES AUTHORITY FOR RECYCLING COLLECTION AND DISPOSAL SERVICES**

**WHEREAS**, the Township of Mendham requires RECYCLING COLLECTION AND DISPOSAL SERVICES to meet its statutory recycling activities; and

**WHEREAS**, studies have determined that a cost effective and efficient method of providing these services is through a Shared Services Agreement with another governmental agency wherein the economies of scale result in a reduced municipal cost; and

**WHEREAS**, the Township of Mendham bid out recycling collection and disposal services and received a proposal from the Morris County Utilities Authority for recycling collection and disposal services through a shared service agreement that was more cost effective than the bids received from two vendors; and

**WHEREAS**, it is necessary to set forth the terms and conditions and procedures for the for recycling collection and disposal services between the Morris County MUA and the Township of Mendham which are a party to this Agreement; and

**WHEREAS**, the Interlocal Services Act (N. J. S. A. 40:65-1 et seq.) provides the mechanism for local governments to enter into contracts for the joint provision of required services.

**NOW THEREFORE BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM, COUNTY OF MORRIS, NJ AS FOLLOWS:**

1. The RECYCLING COLLECTION AND DISPOSAL SERVICES Shared Service Agreement between the Township of Mendham and the Morris County Utilities Authority attached to and made a part of this Resolution is hereby approved, the Mayor is Authorized to execute the same on behalf of the Township, and the Township Administrator is authorized to take the necessary actions to implement the Agreement.
2. A certified copy of this resolution and the Recycling Collection and Disposal Contract is to be provided to the Morris County Utilities Authority for their approval and implementation.
