

### RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM APPROVING CONCEPT PLAN 1 FOR THE INTERSECTION SAFETY IMPROVEMENTS TO AT TEMPE WICK ROAD AND COREY LANE

**WHEREAS,** the Morris County Department of Public Works, Division of Engineering and Transportation has proposed safety improvement at the intersection of Tempe Wick Road and Corey Lane to correct sight distance problems causing a traffic hazard to motorist; and

WHEREAS, French and Parrello Associates, the design engineers for this project have proposed two alternate improvement plans; and

**WHEREAS,** after reviewing the plans and discussing the impact on adjacent property owners the Township Committee believes that Concept Plan #1 is in the best interest of the Township.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM, COUNTY OF MORRIS, New Jersey** that the Mayor is authorized to advise the County of Morris, Dept. of Public Works, Division of Engineer, that the Township supports Concept Plan #1 for the traffic safety improvements at the intersection of Tempe Wick Road and Corey Lane and will finance the estimated municipal share of \$28,300 in this project.

#### **RESOLUTION 2020-162**

RESOLUTION OF THE TOWNSHIP OF MENDHAM, COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN SERVICE CONTRACT WITH CIVIL SOLUTIONS FOR THE DEVELOPMENT OF A NEW DIGITAL, STATE-CERTIFIED TAX MAP IN AN AMOUNT NOT TO EXCEED \$70,000

**WHEREAS**, the Township Tax Assessor has determined the need to develop a new digital state-certified tax map in order to proceed with a tax reassessment; and

**WHEREAS**, Civil Solutions of Hammonton, New Jersey has the necessary experience and credentials to accomplish the development of a new digital, state-certified tax map; and

**WHEREAS**, the purchasing agent has determined that the value of the services exceeds \$17,500 and the contract to be awarded as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 and 20.5 as appropriate; and

WHEREAS, the purchasing agent has determined the contract is exempt from public bidding per Local Public Contracts Law N.J.S.A. 40A:11-5(c); and

WHEREAS, Civil Solutions has completed both a Political Contribution Disclosure Form and a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Mendham with the elected officials in the previous one year, and that the contract will prohibit Civil Solutions from making any reportable contributions through the term of the contract; and

**WHEREAS**, the Chief Financial Officer has certified as to the availability of funds for these services, said funds to be encumbered from account numbers 0-01-55-901-009.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mendham as follows:

- 1. The Mayor & Township Clerk be and are hereby authorized to execute a contract with Civil Solutions of Hammonton, New Jersey for the development of a new digital, state-certified tax map.
- 2. The Chief Financial Officer has certified to the availability of funds for these services.
- 3. This contract is awarded without competitive bidding as an "Exception" pursuant to N.J.S.A. 40A:11.5(c) and non-fair and open pursuant to the provisions of N.J.S.A. 19:44A-20.4 and 20.5 as appropriate, not to exceed \$70,000.
- 4. That a notice of this action shall be published in accordance with law, and said notice to provide that the contract awarded and this resolution authorizing same are available for public inspection in the office of the Township Clerk.

### RESOLUTION 2020-163 RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM AUTHORIZING DISCUSSION WITHOUT THE PRESENCE OF THE PUBLIC

**WHEREAS**, the Open Public Meetings Act permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist; and

WHEREAS, the Township Committee wishes to discuss without the presence of the public the following:

**N.J.S.A. 10:4-12.b (7)** – Matters Falling within Attorney-Client Privilege – Sewer System East pending or anticipated litigation or contract negotiation other than in subsection b. (4) herein in which the public body is, or may become, a party, or matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer; and

#### N.J.S.A. 10:4-12.b (8) – Personnel Matter – Administrator Position

(8) matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of, promotion, or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that the matter or matters be discussed at a public meeting.

**NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of Mendham, in the County of Morris, New Jersey that the Township Committee shall meet in executive session, from which the public shall be excluded, for the matters mentioned above.

**BE IT FURTHER RESOLVED,** minutes will be kept and once the matter involving the confidentiality of the above no longer requires that confidentiality, then the minutes can be made public.
