ORDINANCE 03-2020 TOWNSHIP OF MENDHAM MORRIS COUNTY – NEW JERSEY

AN ORDINANCE OF THE TOWNSHIP OF MENDHAM PROVIDING FOR THE MILLING AND PAVING OF WOODLAND ROAD AND APPROPRIATING \$280,000 THEREFORE, INCLUDING \$252,000 FROM THE STATE OF NEW JERSEY DEPARTMENT OF TRANSPORATION AND \$28,000 FROM THE CAPITAL IMPROVEMENT FUND

BE IT ORDAINED by the Township Committee of the Township of Mendham, in the County of Morris, New Jersey, as follows:

Section 1. The funding for the Milling and Paving of Woodland Road is hereby authorized and such cost is not to exceed \$280,000.

Section 2. The funding for the Milling and Paving of Woodland Road is hereby appropriated from Funds Due from the State of New Jersey Department of Transportation in the amount of \$252,000 and from Capital Improvement Fund in the amount of \$28,000.

Section 3. This ordinance shall take effect following passage and publication as provided by law.
