WHEREAS, the Township of Mendham has a need to hire a certified and experienced Chief Financial Officer / Qualified Purchasing Agent; and

WHEREAS, PHOENIX CONSULTING GROUP will provide recruitment services to accomplish this employment at a cost of \$12,000; and

AN ORDINANCE TO AMEND AND SUPPLEMENT ORDINANCE 12-2019, ENTITLED:

"AN ORDINANCE OF THE TOWNSHIP OF MENDHAM PROVIDING FOR THE MILLING AND PAVING OF
COLD HILL ROAD AND APPROPRIATING \$380,000 THEREFORE, INCLUDING \$332,000 FROM THE STATE
OF NEW JERSEY DEPARTMENT OF TRANSPORTATION AND \$48,000 FROM THE CAPITAL
IMPROVEMENT FUND" TO REFLECT ADDITIONAL FUNDING SOURCES

WHEREAS, ordinance 2019-12 provided funding for the improvement of Cold Hill Road; and

WHEREAS, the Township has received additional funding from N.J. American Water Company to pay for inspection and restoration services for the portion of Cold Hill Road scheduled to be repaved in ordinance 2019-12 due to the installation of a new water main in this road and the Township Auditor is requiring the original ordinance be revised to reflect this additional scope of work.

BE IT ORDAINED by the Township Committee of the Township of Mendham, in the County of Morris, New Jersey, that Ordinance 2019-12 is hereby amended to read as follows:

Section 1. The funding for the Milling and Paving of Cold Hill Road is hereby authorized and such cost is increased from to exceed \$380,000 to not to exceed \$474, 638.02

Section 2. The funding for the Milling and Paving of Cold Hill Road is hereby appropriated from Funds Due from the State of New Jersey Department of Transportation in the amount of \$332,000 and from Capital Improvement Fund in the amount of \$48,000 and from receipts received from N.J. American Water Company of \$94,638.02.

Section 3. This ordinance shall take effect in December 2020 when the N.J. American payments are received

Section 4: This ordinance shall take effect following passage and publication as provided by law.

ORDINANCE NO. 02-2021

AN ORDINANCE OF THE TOWNSHIP OF COMMITTEE OF THE TOWNSHIP OF MENDHAM SUPPLEMENTING CHAPTER 10 OF THE CODE OF ORDINANCES, ADMINISTRATION OF GOVERNMENT, TO ESTABLISH A NEW SUBSECTION 10:47 FINANCE ADVISORY COMMITTEE

WHEREAS, over the past several years, the Township Committee has worked with resident volunteers on an Ad Hoc basis to assist the Township Committee in the municipal budgetary and capital planning processes; and

WHEREAS, this Ad Hoc Committee has been referred to as the Mendham Township Finance Committee; and

WHEREAS, the Finance Committee has assisted the Township Committee in conducting a transparent budget process through budget workshops and open discussions of department requests; and

WHEREAS, the Finance Committee has worked with the Mendham Township Chief Finance Officer (CFO) to develop a budget to introduce at the Township Committee level; and

WHEREAS, the Mendham Township Committee would like to formalize the Finance Committee as one of its standing committees; and

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Township Committee of the Township of Mendham, the County of Morris, NJ as follows:

SECTION ONE: - Chapter 10, Administration of Government, of the Code of Ordinances of the Township of Mendham is hereby supplemented by a new Subsection:

10-47: THE FINANCE ADVISORY COMMITTEE:

A. CREATION.

There is hereby created a Finance Advisory Committee of the Township of Mendham

B. MEMBERSHIP.

(1) - The Finance Advisory Committee of the Township of Mendham shall be composed of 7 members to be appointed as follows:

Class I: Up to 5 residents of the Township of Mendham, appointed at large by the Mayor and the Township Committee for a term of one year, said terms to commence on January 1st of each year.

Class II: The Mayor or his/her designee and the appointed Finance Liaison of the Township Committee.

- (2) In addition to the appointed membership, the Township Administrator and the Township Chief Financial Officer shall be ex officio members of the Finance Advisory Committee with the authority to attend all meetings of the Finance Advisory Committee, and to render advise and comment as appropriate.
- (3) In the event that any member of the Finance Advisory Committee shall resign or be unable to serve for any reason, the vacancy created thereby may be filled for the remainder of his/her term by the Township Committee.

C. POWERS AND DUTIES.

It shall be the duty of the Finance Advisory Committee of the Township of Mendham to:

- (1) Work in concert with the Township Committee to review discretionary budget requests of the Mendham Township Staff, Departments, and Volunteers Organizations.
- (2) To provide an additional perspective on budget requests and the financial needs of the Mendham Township community.
- (3) Other projects as directed by the Township Committee.
 - D. MEETINGS; OFFICERS.
- (1) Meetings shall be held at such time and place as determined by the committee during their first meeting in January following the Mendham Township Committee Reorganization meeting.
- (2) The Mayor or his/her designee will be responsible for chairing the committee and ensuring that meetings are advertised and minutes are taken.
- (3) Since the Finance Advisory Committee contains less than a quorum of the Township Committee, the committee meetings are not subject to the Open Public Meetings Act; however, since the subject matter of the Finance Advisory Committee is the finances of the Township, all operations and capital budget hearings and deliberations shall be open to the public. The schedule of Finance Advisory Committee meetings shall be listed on the Township Website. The Finance Committee may decide at the committee's will to begin a meeting or recess a meeting to closed session.

SECTION TWO:

If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason found to be unconstitutional or unenforceable, such decision shall not affect the remaining portion of this ordinance.

SECTION THREE:

All ordinances of the Township of Mendham which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION FOUR:

This ordinance shall take effect upon final passage and publication thereof as provided by law.
